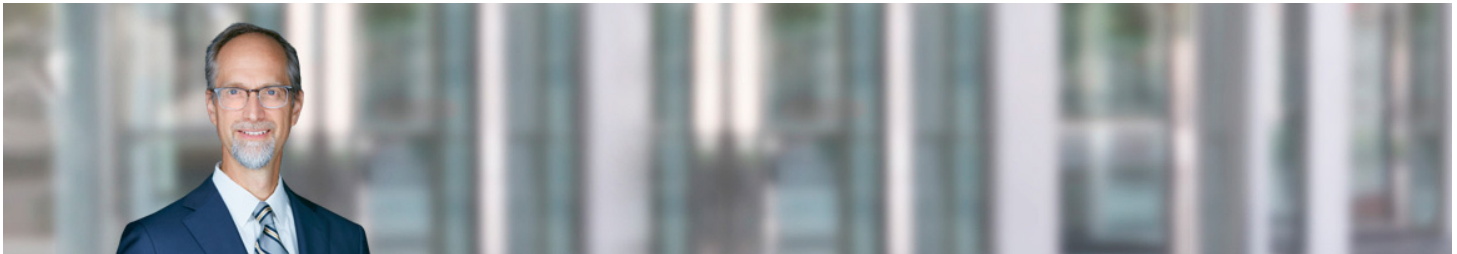

### OVERVIEW

### REPRESENTATIVE EXPERIENCE

Successfully defended developer in federal court against multinational corporation seeking to enjoin residential waterfront development project. After Darrin obtained the denial of plaintiff's motion for temporary injunction and briefed the matter before the 11th Circuit Court of Appeals, the plaintiff dismissed its complaint and appeal with prejudice, and recorded a consent to residential development in the public records.
