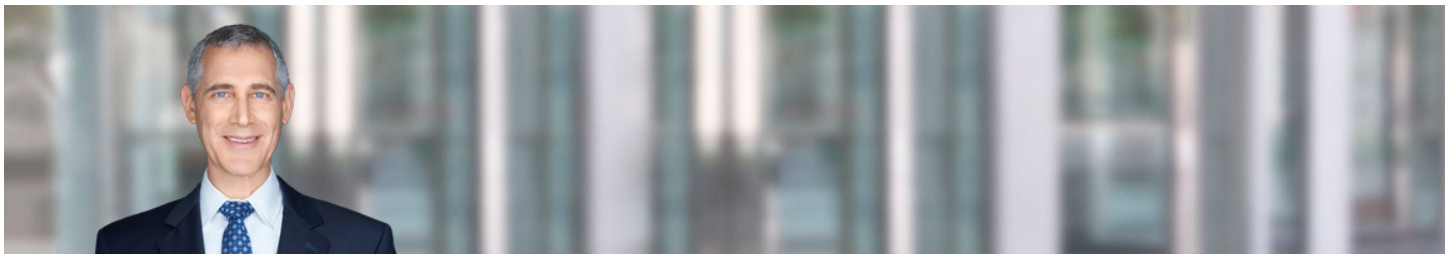

### OVERVIEW
